## From the Editor

As you know, I served as interim editor of this newsletter over the course of this summer. Thanks to one and all for the many kind words, as well as your steadfast encouragement. I appreciated the opportunity to serve in a way that was a good fit with what I am able to do.

The time has come to pass the torch to the new editor of the Voter. Please welcome [Wendy Covich!](#) Wendy has a background in both journalism and graphic design. She brings a terrific new energy not only to this publication, but to the entire chapter of our League.

This is a good time to mention some topics that Wendy will be covering over the next several months. Many terrific programs were approved at the July 27 program planning meeting:

1. Monitor the City of Elgin's efforts to be sustainable. We will also co-sponsor and work on the global 10-10-10 event spearheaded by [350.org](#). With guidance from the Elgin Community Garden Network, and partnering with Elgin Climate Change Organization (ECCO), we will plant garlic and improve trail conditions at Hawthorn Hill Nature Center on this day.

2. LWVEA and the YWCA will conduct a workshop on Running for Public Office: A Woman's Focus at the YWCA on six consecutive Wednesdays starting on January 19, 2011. Loni Mecum, Sigi Psimenos, Wendy Covich, and Dr.

Tana Durnbaugh are working on this project.

3. The Mental Health Committee, composed of Darlene Bakk, Myra Becker, Sandy Kaptain, and Betsy Thrasher, will be working on the mental health/geriatric housing issue. Problems have been reported at three area nursing homes: Maplewood, S. Elgin Rehab., and Asta House.

4. Myra Becker, Sandy Kaptain, Ann Schneck, and Donna Askins will survey LWVEA members on energy and climate change. This may take the form of one of the carbon footprint measures already identified by the LWV-US.


5. Under consideration is a study of whether a new Senior Center is needed for Elgin. This effort will be chaired by Janet Poyner.

6. Potential gravel mining on the Brunner property is another proposed issue. Whether a study is needed will be ascertained after the November elections. Carol Grom, chair, will be assisted by Sigi Psimenos and Darlene Bakk.

7. A Feb. 7 report on the use of Elgin impact fees has been scheduled by Janet Poyner. Loni Mecum believes the City may provide this information easily.

8. Finally, at the federal level, we may be developing a program regarding the Federal role in public education. Sigi Psimenos, Dennis Schwank, and Laurel Bault will assist.

The torch of democratic justice is alight, but all hands are needed to hold it high. Get involved. Let our light shine!

- d. 100-200 years or more


3. Which is the target level the top climate change scientists are recommending to protect us from too much climate change?

## Immigration Reform

On Tuesday, August 31, 2010, at 7:00 p.m. the League of Women Voters of the Elgin Area will host an informational program for



members regarding Comprehensive Immigration Reform and what role we can play in support of the national and state Leagues of Women Voters' positions regarding this very important issue. The presentation will focus on the current legislative status of Comprehensive Immigration Reform. The need for local grass roots action will be reviewed and encouraged.

This will include a request for the Elgin LWV to consider its own local response consistent with the positions taken by the national and state LWV.

Royce Blackwell and Shirley Sadjadi, members of the Elgin Ad Hoc Committee for Comprehensive Immigration Reform, will talk about the current status of immigration reform legislation in Congress, personal examples of inequities in the current law, and strategies to show support for change. A Question and Answer session will be included.

The program will be at Tyler Towers Clubhouse, 1450 Plymouth Lane, Elgin, Illinois. The clubhouse is a single-story building behind Tyler Towers.

## Financial News

As of the end of July, we have a total of 71 paid members: 48 individuals, 11 couples and 1 student. In addition to dues paid, we have received donations from members totaling \$310. And, members raised a net \$115 during 'Together We're Elgin.' The Annual LWVIL Phonathon brought us \$69. We welcome your ideas for helping us raise additional money.

Some of you may recall that the Carpentersville-Dundee LWV quoted a figure of \$3,000 that would remain of their funds upon

their eventual dissolution and merger with us. After they paid their state and national dues and other expenses, there actually remained \$1825. Their account is now closed and that money is in a savings account along with our funds at the Kane County Teachers Credit Union. This money will help us continue Voter Services programs in Dundee and Rutland Townships.
